## FEATURES:

*At-Risk* includes a number of unique features to assist the institution in implementing the program and assessing its impact. They include:

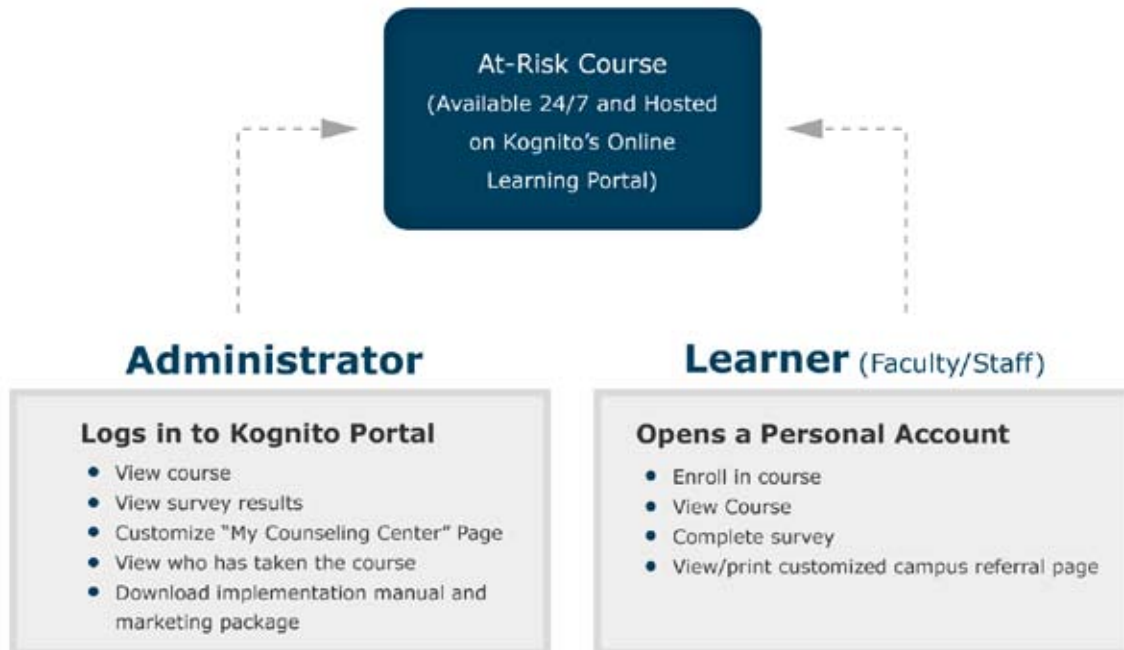
- An implementation manual, which includes a marketing package, created by Kognito, to assist you in announcing and marketing the course within your institution. This package includes suggested language for an email announcement, a customizable flyer, a PowerPoint presentation, and a short, web-based narrated trailer to create excitement about this interactive resource.
- An anonymous online survey which collects self-reported feedback from your users about their learning experience. This survey is optional for users to participate in.
- A customizable “My Counseling Center” HTML page. You can choose which information to include in this page. This information can include the counseling center’s contact information / location, campus-specific policies, and information about your behavioral intervention team. Users will be able to view/print this page for their records.
- Access to tracking system to view the names of those in your institution who have launched and completed the training.
- A facilitator’s manual for those interested in conducting follow-up group discussions.

- An automatically generated Certificate of Completion
- As part of the service provided by Kognito, each institution will receive free technical support via phone and e-mail and well as free software upgrades during the term of the license.

## ACCESSING THE COURSE:

Kognito will provide each institution with two types of accounts: (1) administrator account, and (2) learner account. As illustrated below, the administrator account will provide access to the course, survey results, customized counseling center page, tracking system to view those who launch and complete the course, and (5) access to the implementation manual and marketing package.

Each learner will create their own account by logging into Kognito’s online learning portal and then enrolling in the course using an enrollment key provided by Kognito to the institution. Within their password-protected account, learners will be able to access the course from any computer with an internet connection. The Kognito online learning portal records the progress of each learner thereby allowing learners to complete the training in multiple sittings.



## OPTIONAL FEATURES:

Institution can choose to add a 1-2 minute narrated and animated introduction piece which will be viewed by their learners at the beginning of the course. This introduction can include a message from the President or VP of Student Affairs communicating the importance of this training and, if relevant, informing learners about the institution's behavioral intervention team and other relevant initiatives. The cost of this feature is estimated at \$1,850 - \$3,000.
